Who Is Eligible

- A copy of your SAT and/or ACH test scores
- A letter of recommendation from a teacher, counselor, or administrator
- Your resume that should include (dates for each)
 - community/voluntary service
 - extracurricular activities
 - academic awards/achievements
 - employment
- An essay, not to exceed 500 words, of the value of Credit Union membership and the role Credit Unions play in the financial world.
- Please do NOT include any photos with your application.
